Gap	Up to \$1,200 or state max
ESC	<ul style="list-style-type: none"> <li>Minimum contract term must be 24 months/24,000 miles and must include coverage for seals and gaskets</li> <li>Warranty can be sold for a max of \$4,000 (cars); \$5,000 (trucks); \$6,000 (diesel trucks)</li> </ul>
Insurance Deductibles	Max \$1,000 Comprehensive/Collision
Proof of Residence	<ul style="list-style-type: none"> <li><b>POR is not required for Vamos or Classic programs. Applicant is required to add a GPS/SI device on the vehicle.</b></li> <li>One form of standard POR with applicant's name and stated residence required dated within the past 30 days (Electric/cable/water bill, bank statement, phone bill, credit card, medical bill, etc.). Junk mail will NOT be accepted. (BK program &amp; NV residents)</li> </ul>
Proof of Income	<ul style="list-style-type: none"> <li>Bank statements must be validated through Turbo Pass</li> <li>Must prove 75% of income stated in applications (Vamos program only)</li> <li>Job letter accepted with \$500 fee (Vamos program only)</li> <li>3 most recent canceled checks (copies of front and back of cashed checks)</li> </ul>
Ineligible & Restricted Vehicles	<ul style="list-style-type: none"> <li>Rebuilt, branded/salvage, lemon law, gray market/unknown mileage, total loss, flood damaged vehicles, airbag deployment, insurance auction — including taxis, limousines, police cars, delivery vehicles, tow, ride sharing vehicles, and all discontinued lines — are all ineligible</li> <li>Frame/structural/unibody damage vehicles accepted with 2-payment recourse</li> </ul>
Blackout Period	First payment due date may NOT fall after the 25 <sup>th</sup> of the month.
