ESC	<ul style="list-style-type: none"> Minimum contract term must be 24 months/24,000 miles and must include coverage for seals and gaskets Warranty can be sold for a max of \$4,000 (cars); \$5,000 (trucks); \$6,000 (diesel trucks)
Insurance Deductibles	Max \$1,000 Comprehensive/Collision
Proof of Residence	<ul style="list-style-type: none"> POR is not required for Vamos or Classic programs. Applicant is required to add a GPS device on the vehicle. One form of standard POR with applicant's name and stated residence required dated within the past 30 days (Electric/cable/water bill, bank statement, phone bill, credit card, medical bill, etc.). Junk mail will NOT be accepted. (BK program & NV residents)
Proof of Income	<ul style="list-style-type: none"> Bank statements must be validated through Turbo Pass Must prove 100% of income stated in applications Job letter accepted with \$1,000 fee and 3-payment recourse (Vamos program only) 3 most recent canceled checks (copies of front and back of cashed checks)
Ineligible & Restricted Vehicles	<ul style="list-style-type: none"> Rebuilt, branded/salvage, lemon law, gray market/unknown mileage, total loss, flood damaged vehicles, airbag deployment, insurance auction — including taxis, limousines, police cars, delivery vehicles, tow, ride sharing vehicles, and all discontinued lines — are all ineligible Frame/structural/unibody damage vehicles accepted with 2-payment recourse
Blackout Period	First payment due date may NOT fall after the 25 th of the month.
